### November 2019

Great Progress is taking place in District 110! Here are a few highlights:

**Seals/Bonds Gully Channelization Project:** HCFCF has issued a maintenance contract for repairs of Seals Gully, K-124-00-00-X036, and contractor has begun work. This is a channelization project begins on the south side of Cypresswood Drive and proceeds downstream approximately 1900 feet. The project includes reconstruction of the side slopes and replacement of most of the backslope drains. It does not include the outfall of seals into Cypress Creek. Both east and west sides of the gully will be repaired.

**Seals/Bonds Gully Additional Detention. West Side of District 110:** Additional detention on the east side of Seals/Bonds Gully is being looked at. Request for existing infrastructure has been requested from Center Point Energy for electrical and gas facilities. According to HCFCF, additional detention in this location would help reduce the upstream base flood elevations north of Cypresswood. Detention in this area would not change the base flood elevation near confluence with Cypresswood Creek due to hydraulics of Cypress Creek.

**Hardy Toll Road at Cypress Creek:** HCTRA has completed channelization work on both sides of Cypress Creek underneath the Hardy Toll Road. Construction was done by Lecon Construction. This project included concrete rip rap, hard edge treatment on lower sections of stream banks, new storm drain outfalls, and removal of sedimentation on both side of Cypress Creek. Improvements have lowered low flow levels about two feet as evidence at IFID Storm Pump Station outfall.

**Cypress Creek Erosion repairs from Hardy Toll Road upstream (westerly) approximately 4000 feet to the down stream side of Lemm Gully confluence with Cypress Creek:** HCFCF has issued a maintenance contract for erosion and channelization repairs of the Cypress Creek main channel from west side of the HCTR upstream approximately 4000 feet. This project includes

concrete rip rap hard edge treatment on lower sections of stream banks, replacement of storm drain outfalls, correcting flowline issues, and removal of sedimentation on both side of Cypress Creek. Construction began in September 2019 and is anticipated to be complete end of 2020.

**Haas and MUD 249 Detention pond expansion. East side of District 110:** HCFCF has expressed interest in excavating additional volume for this pond. We will be setting up a meeting with HCFCF to develop an agreement to get this work started. Draft agreements have been produced.

**Senger Gully Channelization Repairs. Central area of District 110:** Channelization repairs along Senger Gully from I-45 northwesterly to Cypresswood drive have been completed by HCFCF and Lecon construction. Harris County is also studying some additional detention ponds along Senger Gully.
